

Dr Professor of Greek- Roman and Islamic Law Kyriacos Th. Nicolaou-Patragas studied in the Faculty of Law of Athens University and has Master degree in History of Law and PhD in the Greco-Roman and Islamic Law of the same faculty. His interests are directed towards Islamic Law and in general issues of Islam, Greco-Roman Law, the Justinian's Corpus Iuris Civilis, as well on the area of the Arab world and ideological directions in it.

He is the director of the Laboratory of GrecoRomanum and Islamic Law of the University of Athens. He is also teaching in the Military and Security Forces schools of Greece and he is a chair professor of Rifaat al-Said Islamic Studies in EPLO.

His authorship includes about 30 independent publications, 70 scientific articles, 4 translations, 12 works as an editor. He is also the Director of the magazine "Nomika Polyptiha".

Εἶνε διευθυντὴς τοῦ Ἑργαστηρίου Ἑλληνορῶμαϊκοῦ καὶ Ἰσλαμικοῦ Δικαίου καὶ τῶν ἀντιστοίχων πολιτισμῶν τοῦ Πανεπιστημίου Ἀθηνῶν.. Ὡσαύτως διδάσκει εἰς τὸ σύνολον τῶν παραγωγικῶν σχολῶν τῶν Ἑνόπλων Δυνάμεων καὶ τῶν Σωμάτων Ἀσφαλείας τῆς Ἑλλάδος καὶ κατέχει ὡς καθηγητὴς τὴν ἔδραν Ρέφαατ ἁλ-Σαῖντ τοῦ EPLO.
